As per our Bye Law - Chapter II

9. Applications for membership shall be made in the prescribed form approved by the Executive Committee and shall be submitted to the Executive Committee. The Executive Committee shall decide all questions relating to eligibility of membership of any applicant and its decision shall be final. An applicant for membership of the Association shall be recommended by a member and an Executive Committee member. A member shall nominate one individual to represent on their behalf in the Association as the Authorised representative in the format prescribed by the Executive Committee along with Photograph. He/She should be the Proprietor/Partner/ Director or CEO of the member. Any change in such representation shall be informed in writing to the Association.
- (i) The Executive Committee, for this purpose, shall form a membership committee of five members who have enough experience in this connection with atleast two Past Presidents. This Committee shall scrutinise the application and submit its report to Executive Committee, within thirty days and the decision of Executive committee shall be final.

(ii) In case of inappropriate behavior by an authorised representative he/she may be removed by the Executive Committee. The member industry may appoint another authorised representative in his/her place.

(iii) Applicants for membership as Industrial Member shall be admitted as Associate member. They can become Industrial member only after one year of admission. A member can become a Life Member only after being an Industrial Member for one year.

- Membership subscription will be received only after getting approval in Membership Committee.
- Membership Certificate will be handed over in person to Authorised Representative @ CODISSIA Office.
